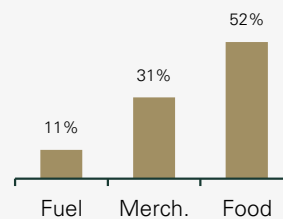

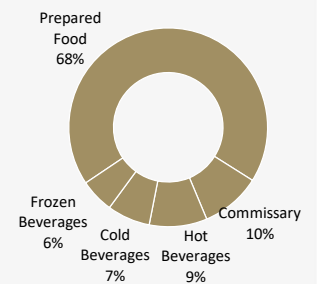
- 1) Modern c-store blurring the lines between convenience, drug, dollar, grocery, liquor and QSR

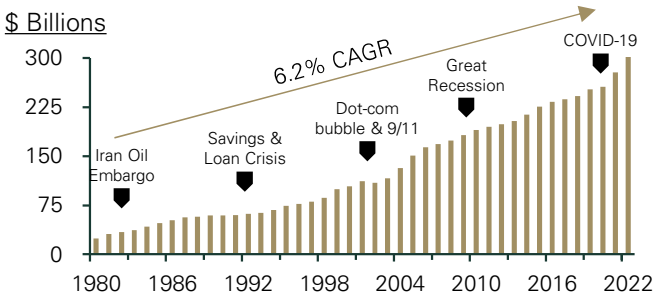
Gross Profit Margins
